

VOLUNTEER AGREEMENT WAIVER AND RELEASE OF LIABILITY

The above-named Volunteer agrees to help in the 2018 USA Track & Field Junior Olympic National Championships (hereinafter "USATF-JO"). I understand the Volunteer's participation in the USATF-JO involves a potential risk of injury. I acknowledge and assume all risks associated with participating in USATF-JO, including, but not limited to, falls, contact with other volunteers, participants or officials; the condition of the premises and/or of the equipment used; and extremes of temperature and humidity. There may be OTHER RISKS inherent in USATF-JO, whether foreseeable or not known or not reasonably foreseeable. Understanding all of the above, the undersigned, individually and as the parent or guardian of the Volunteer, hereby expressly assumes all risks associated with the Volunteer's participation in USATF-JO including all risks associated with track and field including the equipment involved, and including travel en route to and from USATF-JO.

Despite my understanding of the foregoing risks, the undersigned, individually and as the parent or legal guardian of the Volunteer, agrees not to sue and to release from liability and to defend, indemnify and hold harmless the USA Track and Field, their respective Board of Directors, representatives, employees, volunteers, officials, sponsors, advertisers, agents and any other persons affiliated with USATF-JO for any damage or injury arising out of the Volunteer's participation in USATF-JO regardless of the cause, even though the liability may arise out of negligence or fault on the part of the persons identified in this waiver. Volunteer intends and agrees that this release is as broad and as inclusive as permitted by applicable law, and if any portion thereof is invalid, Volunteer intends and agrees that the balance shall continue in full legal force and effect.

I hereby grant and convey unto USATF-JO all right, title, and interest in any and all photographic images and video or audio recordings made by the USATF-JO and any person acting under its direction, and/or USATF-JO during the my activities with the USATF-JO, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings. Additionally, I acknowledge that media will be present, and that by participating in USATF-JO, my photograph, likeness, and/or voice may appear in documentary, promotional (including and all advertisements) television, radio or film coverage of USATF-JO, without compensation.

I hereby release and forever discharge the USATF-JO, USA Track and Field from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my activities with the USATF-JO. In the event of injury, I hereby consent to emergency medical treatment.

I understand that the foregoing is legally binding in consideration of participation in USATF-JO, and I sign this Agreement of my own free will.
